

Instructions for the Advanced Visual Neuroscience (NEUR 3001) practical

Two options:

OPTION ONE: PERCEPTUAL EXPERIMENTS

Use PXLab (JAVA software to be copied to your computer) to run the series of experiments listed below. For each experiment, *briefly* outline in a about single paragraph (perhaps more for longer experiments), the experimental technique, the results you obtain, and what you think they might mean. This is a practical book, so extensive references and background reading are *not* required. Just make clear that you have carried out the experiment, and that you have thought about the results.

No more than about 5 sides of A4, please!

This is a new option, so we would welcome suggestions for improvements. Potentially, you could even edit the program files yourself (see PXLab website for further information).

You can do the experiments individually or in small groups. Extra credit will be given if you compare results across students.

If you find the setup and other instructions challenging, or if you cannot get the experiments to run on your computer, then you can try running the software directly from the website (see below, but the Stroop experiment is in German). Alternatively, the experiments will be running on computers in my laboratory at the Institute of Ophthalmology. Contact me if you want to use them. And, of course, you can also choose Option Two!

These experiments should run on your computer, but they require Java to be installed. The details follow:

Four Steps to Run PXLab Applications

1. Make sure that you have the latest Java software installed. You can check this by going to <http://www.java.com>, the main page for the Java runtime environment (JRE). Select 'Do I have Java?' from the choices offered on the page, then (if you have Java) press the button "Verify Java version" on the subsequent page. If the website response tells you that you have the latest Java then go to the next step (2). If you do not have the latest Java software, then download the latest Java runtime environment. Use the 'Typical setup' installation option and again use 'Do I have Java?' to check whether the installation was successful.
2. To get the experimental programs go to <http://www.cvrl.org> go to NEUR3001 and scroll down to beneath the list of lecturers to find the information about the practical. The information (this information) is contained in a pdf file. To get the software, download and save the zip file "pxlab.zip". Unzip it onto your hard drive or onto a memory stick, keeping the same directory structure. Keep a note of where it is! The distribution contains a number of programs that run psychophysical experiments.
3. Use your file explorer to find the file named `pxlab.jar` in the `/pxlab` directory (wherever you have unzipped it—note that the extension `jar` might be hidden in Windows). Double click on this file (with the Java icon) and the program will start an Open Design File dialog. If it isn't already selected, go into the subdirectory named `/pxlab/pxd` and choose a design file (a file with extension `.pxd`) from this subdirectory and the experiment will start. The file names and the experiments are listed below. Do not run the design files until you have read the instructions for the experiment given below!
4. You only need to look at the data files for a few experiments (as noted below). The raw data obtained during an experiment are saved in `/pxlab/dat/pxlab.dat`. If you want to look at the data, open the file with a text editor or other editor, and note down the data. Structured data obtained during an experiment are saved in `c:/pxlab/dtr/pxlab.dtr`. Also open this file with a text editor or other editor, and read the data. You only need to look at the

structured data for the Stroop experiments (see below). Note that these data files are overwritten after each experiment, so you should record the data before running a new experiment. You will only need to look at these files for some experiments, as noted below.

You can also run the experiments directly from the website from Internet Explorer or Mozilla Firefox. Go to: <http://www.pxlab.de/> and follow the instructions there. You will need to allow pop-ups in your browser in order to be able to see the data after each experiment, which appear in a pop-up window.

The downside of using the website is that a few experiments, such as the Stroop experiment, are in German.

The following is a list of the experiments and the relevant `pxd` design files you must run after first running `pxlab.jar`. You do not necessarily need to do every experiment. If some don't work, note the problem you have encountered in the practical book, and move on. And, don't worry, this is supposed to be "fun".

For each experiment, first run `pxlab.jar`, then run the `pxd` file from the dialog.

The Müller-Lyer Figure

Run: `mueller_lyer.pxd`

Two Müller-Lyer objects. Follow the instructions and record the on-screen results, which appear after each run. Do the experiment a few times (5 or more) to obtain a mean and standard error for the changes in apparent length.

Change Blindness: The Flicker Method

Run: `change_blindness_flicker.pxd`

This experiment demonstrates our blindness to stimulus changes across flicker breaks. It is similar to Experiment 1 of Rensink *et al.* (1997). Follow the on-screen instructions.

Note in the practical book which part of the scene changed for each picture pair.

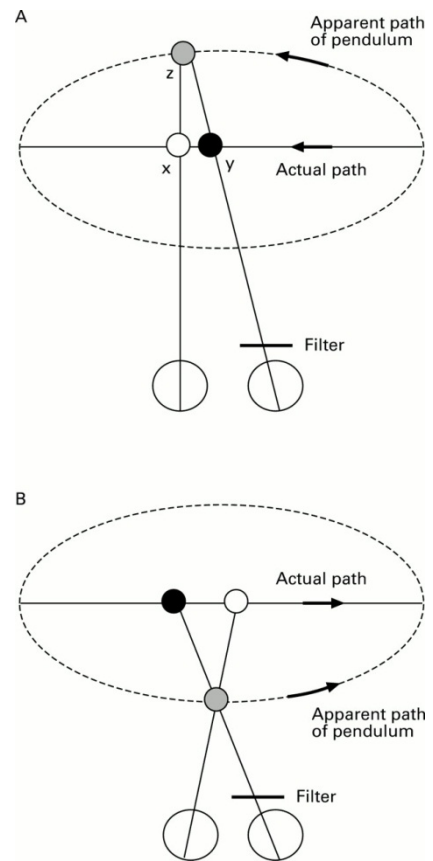

Pulfrich Pendulum Simulation

Run: pulfrich.pxd

This simulates a pendulum swinging in the horizontal plane. You will need to cover one eye with a dark filter (e.g., dark sunglasses) after which the pendulum will appear to swing in depth. Why? See the figure on the right. You will find other examples on the web.



Interocular transfer of Motion After Effect

Run: bene.pxd

Follow the instructions on the screen. Adapt to the moving pattern for 30 seconds with one eye and then view the stationary grating as instructed with either the same eye or the opposite eye. When the after-effect (motion in the opposite direction) disappears press any mouse or keyboard key. The length of the aftereffect is recorded and a delay of 60 s counts down until you can start the next trial. Do about 10 trials.

You will need to open `/pxlab/dat/pxlab.dat` with a text editor or other editor to view the data. The first two lines will look something like this:

```
0    Please view with SAME eye now!    7977.4806
1    Please change to the opposite eye now!    16790.1731
```

The first column is the trial number. The second tells you whether you changed eyes or not. And the third tells you the duration of aftereffect in milliseconds. Average appropriately.

Compare the mean data and standard deviation for the motion aftereffect (MAE) in the same eye with those for the MAE in the opposite eye (the Interocular transfer effect).

Stroop Interference

Run: stroop_short.pxd

This experiment is a non-verbal version of the classical Stroop (1935) task. The number of trials in this version has been reduced to 12. Run this for practice only.

Read the instructions on the screen. When you see the fixation cross, press a mouse button or key to start the trial. If the colour name on the bottom is the same as the “ink” colour on the top, then press the left mouse button. If not, press the right mouse button.

Run: stroop_visual.pxd

Now run the main experiment. Keep going until the end, or press the [stop experiment] key if you get fed up (the data up to that point will be saved).

To look at the results, you will need to open `/pxlab/dtr/pxlab.dtr` with a text editor or other editor to view the data. The data are at the *end* of the file and will look something like this:

Trial( 8, 1, "NLKS", "RED", GREEN, NEUT, R_NO, 0, 811.4323);

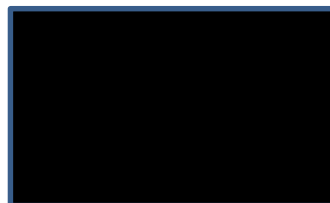

In each line within the brackets, the third element in quotation marks is the *word* that appeared on top, sometimes a nonsense word. The fourth element also in quotation marks is the *word* that appeared on the bottom always printed in white. The fifth word not in quotation marks is the “*ink*” colour in which the upper word was printed.

For example, Trial(6, 1, "BLUE", "RED", RED, INCON, R_YES, 0, 1442.588) would have appeared thus:



and Trial(0, 3, "YELLOW", "GREEN", YELLOW, CON, R_NO, 0, 1882.8742) thus:



The sixth word is important and defines the trial: CON means that the upper colour word and the colour in which it was printed were the same (congruent); INCON means that the upper colour word and the colour in which it was printed were different (incongruent); and NEUT means that the upper word was a non-colour, nonsense word (neutral).

The second from last element (0 or 1) is also important. A 1 means an incorrect response and a 0 means a correct response.

Finally, the last element is the response or reaction time (RT) in milliseconds.

Complicated? Not really! Average separately all the correct CON RTs, the correct INCON RTs and the correct NEUT RTs and compare the results. In the CON trials the ink and word were the same so could “reinforce” each other, perhaps making the RT quicker. In the INCON trials the ink and word are different so could “interfere” with each other, perhaps making the RT slower. The RT for the NEUT trials should be unaffected by the upper word. Is what you find consistent with this?

Adaptive Stimulus Control: The Horizontal-Vertical Illusion

Run: horizontal_vertical_adaptive.pxd

This experiment measures the size of the horizontal-vertical illusion, which is the tendency for observers to overestimate the length of a vertical line relative to a horizontal line of the same length.

The program uses the method of limits in which a staircase tracks your responses by adjusting the length of the vertical line according to your response on the previous trial. If you thought the vertical line was longer, it is made shorter on the next trial, and vice versa. The step size or amount by which the line length is changed is gradually reduced over trials so that the length converges on an estimate of the vertical line length that for you appears to match the horizontal line length.

Record the results of each experiment as shown on the screen. What is the mean relative size of the illusion?

Visual and auditory response times compared.

Run: erzav.pxd

Follow the on-screen instructions. When the run has finished, open the data file: `/pxlab/dat/pxlab.dat` with a text editor or other editor to look at the results. The last column gives the response times (RTs) in milliseconds. The first four rows are auditory RTs and the last four rows are visual RTs. Do the experiment a few times and average the results. Remember to record the results after each run or they will be overwritten.

Compare the visual and auditory response times. Which is quicker?

Choose 15 different illusions. For each illusion, *briefly* outline in a paragraph: the illusion, your observations, and what the results suggest about the visual system. You are writing a practical notebook, so references and extensive background reading are not required. Just make clear that you have observed each illusion and thought about what it means.

No more than about 5 sides of A4, please!

Extra credit will be given for groups of coherent choices that can conceptually be related to each other.
